Waiver of Liability

In consideration of being permitted to participate in any way in the Wrestling Program at Warsaw Community High School:

1. The parent(s) and/or legal guardian(s) will instruct the minor participant that prior to participating in the below wrestling activity or event he or she should inspect the facilities and equipment to be used, and if he or she believes anything is unsafe, the participant should immediately advise the coaches of such condition and refuse to participate.
2. I/we fully understand and acknowledge that:
 - A. There are risks and dangers associated with participation in wrestling events and activities, which could result in bodily injury.
 - B. The social and economic losses and/or damages, which could result from these risks and dangers described above, could be severe.
 - C. These risks and dangers may be caused by the action, inaction or negligence of the participant or others.
3. I/we accept and assume such risks and responsibilities for the losses and/or damages following such injury, disability, paralysis or death, however caused or caused in whole or in part or by the negligence of the releases named below.
4. I/we **HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE.** I/we hereby acknowledge that **THE ACTIVITIES OF THE EVENT(S) ARE VERY DANGEROUS** and involved the risk of serious injury and/or death.
5. Each of the undersigned further expressly agree that the foregoing release, waiver and indemnity agreement is intended to be so broad and inclusive as if permitted by the law of the State in which the event is conducted and that if any portion is held invalid, it is agreed that the balance shall notwithstanding continue in full legal force and effect.
6. On behalf of the participant and individual, the undersigned parent(s) and/or legal guardian(s) for the minor participant execute this waiver and release. I, despite the release, the participants make a claim against any of the releases, the parent(s) and/or legal guardian(s) will reimburse the releases of any money which they have paid to the participant, or on his behalf and hold them harmless.
